1. Meeting called to order at 6:31. Agenda adjustments: none

## 2. Hybrid Zoom In-person meetings:

a. Jacob Trewe has experience with solo hosting of hybrid meetings at several locations including our current in-person JWN meeting location. Jacob will attend in-person meetings and provide online attendance for those who cannot attend in-person. Our first in-person meeting is March 2023. The hybrid meeting platform with be trialed at that time.

# 3. Chair Reports:

a. <u>Chair (Ted):</u> Chair report reviewed. Naval reserve site meeting on Wednesday 12/14 (tomorrow). Homes for Good will present their plans for the buildings. It is noted that JWN started this process in 2009 and it is finally moving forward. Monroe Park permanent two-hour parking signs will be installed, hopefully, by the end of this year. Board elections will be in April. Board members are to think about potential candidates for the Board and Board Chair.
