1. JWN general information:

- a. Thank you to Jacob Trewe for facilitation our first hybrid=Zoom meeting.
- b. Board Elections are at the next month JWN general meeting, Tuesday April 11th.
- c. JWN raised \$7,120 in our green food drive!
- d. Monroe Park Clean Up: Sunday March 26, 9am-12pm
- e. Charnel-Mulligan Park: Trees by the picnic tables were diseased, damaged, and removed. New tree planting planned for Fall 2023. The first clean-up will be in April.
- f. Jefferson Dog Off-Leash Park: Work parties will be planned soon. Park directors will be meeting about future plans for the park.
- g. Lincoln School Park: Renovation planned for this year.
- h. Lane Events Center: Logging Conference: Participants parked on a wet area of grass and destroyed part of the lawn. The area had no-parking signs. LEC is contacting the conference leaders about repairing the area.
- i. If JWN residents have a tent on the parking strip between the sidewalk and street, recommendations: call the non-emergency police line; ask people to move, install a no-camping sign, and/or landscape the area to prevent future camping.
- j. If street residents are concerned about excessive speed on your street, please contact the JWN and a request will be submitted for a speed study.
- k. The annual picnic will be a Tuesday in July.

2. Hosea Youth Services, Brad Bills

- a. A Day-Use Resource Center for 16–24-year-old youth, in the basement of the Grace Fellowship Church. The Youth Services have served over 450 people with greater than 8,000 visits in 2022. The facility provides food, clothing, internet access, showers a place to rest and counselling. The goal is to get the young people off the street.

3. Homes For Good, Matt Salazar

- a. Naval Reserve site has been owned by the city of Eugene since 1930's. In 2009 the building was demolished and JWN requested low-income housing. 2022, the city of Eugene approved the proposal.
- b. The plan is for single, double, triple, and quadruple apartments, an early learning child center and a community meeting room.
- c. HUD has approved a 30% cap on rent for total family income.

4. Lane County Sherriff: Clifton G. Harrold, Lane County Public Safety Jail Levy renewal.
