1. 6:30 - Meeting called to order.

2. 6:30 - 6:35: Introduction of board members.

3. 6:35 - 6:40: Introduction, comments, and announcements from non-board members. Presiding officer will ask non-board members to indicate if they want to speak. 5. 6:45 - 7:00 **Brief reports** from Chair, Treasurer, Secretary, and NLC Rep.

- Chair:
 - Ted spoke to the Faith Center regarding on-street parking and crosswalks in relation to Ollie Court, 14th St
 - Report from LEC meeting. They indicated that the gate can be opened.
 - Ted has been in contact with the owner of the 711 at Polk Street. They will be addressing unhoused issues.
 - Van Buren and West 13 – LEC and Ollie court are for a crosswalk at this location.
- Treasurer: report – Sue provided the report.
- Secretary: Meeting Minutes – **Action:** Meeting minutes were approved.
- NLC Rep: Sandra
 - There was conversation about the closer of the path at Ceaser Chavez and the impact on the neighborhood. It was suggested that the schools have a line of communication to the neighborhoods. Sandra made a motion to have NLC come up with a good neighbor agreement with the neighborhood associations. They would like a draft of a good neighbor agreement. **Action:** Ted will be working with them to create this.
 - They are working on a newly revived Disaster Preparedness committee.

6. 7:00 - 7:20 **Brief committee reports:**

- Neighborhood Matching Grant: no response
- Ted spoke with Community Supported Shelters and plans to speak to Albertsons to come up with a plan to clean up the area.
- Ted spoke to Travel Lane County regarding the Historic District. They were supportive of the concept. Some of the members wanted to look into their agenda prior to being an associate member. It was suggested that we ask where they may use our logo.
